Rationale Submitted by Mover:

The Annual Business Meeting to conduct executive committee elections is one of our planned quarterly in-person meetings. Assuming we rent from Cocoa Beach Offices as was done in the past, the venue costs \$53.25 per hour, so \$200 would give us the necessary ceiling to conduct a 3 hour meeting for \$159.75 plus any minor incidental expenses supporting the event. If we choose a different venue or conduct a shorter Annual Business Meeting, the full budget is not required to be used. This motion assumes we will not be catering the meeting.
